### Primary Purpose

To lead and manage the day-to-day operations of the School Health Nurse Program in accordance with state and national strategic directions, service standards and best practice.

### Level of Responsibility/Direction and Supervision

Responsible and accountable for providing support with the management and leadership of the School Health Nurse Program, maintaining the highest standards of nursing practice in accordance with both the Department's legal and policy requirements and the nurses code of professional conduct.

Required to ensure that the School Health Nurse Program is managed in line with relevant legislation, standards and guidelines, and organisational policy, to ensure a consistent state-wide approach, providing appropriate direction and professional supervision as required for school health nurses.

The occupant operates with considerable independence in day-to-day activities and is expected to demonstrate substantial initiative and judgment. Overall guidance and direction received from the Director of Nursing.

The Department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.

In the delivery of the department's activities, the occupant must ensure that:

- Within the occupant's area of organisational responsibility, appropriate strategies are in place to minimise the risk of fraud; and
- Decisions and actions are made ethically and with integrity, on the basis that such is legal, is right and is reasonable based on an objective standard.

## Primary Duties

---

1. Provide specialist advice to assist the Director of Nursing with the planning and implementation of the School Health Nurse Program.
2. Coordinate, manage and lead the day-to-day delivery of the School Health Nurse Program with a focus on school-wide health promotion, prevention and early detection for students aged Kinder to Year 12.
3. Liaise with principals and local managers and provide advice on matters affecting service delivery.
4. Monitor and manage staff performance and development across all relevant school sites.
5. Ensure the provision of high quality and safe program delivery in accordance with departmental standards applicable to an integrated School Health Nurse Program service, including assisting with the development of policies and in reviewing the implementation of ongoing quality improvement activities.
6. Provide specialist advice in the development, implementation and evaluation of clinical governance frameworks and evidenced-based nursing care models.
7. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

## Selection Criteria

Employment in the State Service is governed by the *State Service Act 2000* and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and
- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Demonstrated ability to apply advanced knowledge and skills in relation to school health nursing, including the ability to plan, develop, implement, and evaluate the program at an individual and group level, together with the commitment to leadership in continuous quality improvement, particularly in an education environment.
2. Demonstrated effective leadership skills and the capacity to set clear directions, make sound decisions, and deliver outcomes within available resources.
3. Demonstrated highly effective skills and experience in administrative, financial, human, physical and resource management.
4. Highly developed interpersonal skills including oral and written communication, negotiation, and conflict resolution skills, including the capacity to initiate change, exercise sound judgement and solve problems.
5. Proven ability to be proactive and self-directed, adaptable, flexible and exercise considerable initiative to achieve results and balance competing priorities in a complex environment.

## Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times by the occupant who is assigned these duties. The status of these essential requirements may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Department if their circumstances change. This includes notifying the Department of any new criminal charges or convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.

### Essential

- Registration with the Nursing and Midwifery Board of Australia.
- The *Registration to Work with Vulnerable People Act 2013* requires persons undertaking work in a regulated activity to be registered. A regulated activity is a child related service or activity defined in the *Registration to Work with Vulnerable People Regulations 2014*. This registration must remain current and valid at all times whilst employed in this role and the status of this may be checked at any time during employment.
