### Primary Purpose

Work in Tasmanian Government schools, Child and Family Centres (CFCs) and community locations to provide support to children and families affected by family violence.

Contribute to capacity building in CFCs, schools and communities to improve understanding of the impact of family violence and trauma on learning and well-being.

### Level of Responsibility/Direction and Supervision

The occupant is responsible to the Supervisor for the effective delivery of social work services within the Safe Homes, Safe Families program and the professional management of the assigned caseload.

An occupant at Level 2 performs a variety of tasks of a novel, complex or critical nature, and exercises independent professional judgment to resolve complex problems or issues.

The Department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.

## Primary Duties

---

1. Provide professional and direct advice and services such as counselling, mediation, advocacy, advisory and information service for schools and CFCs, students and families/care givers to improve the wellbeing of children who are impacted by family violence.
2. Respond to and assist schools and the Learning Service in their response to issues related to the impact of family violence.
3. Liaise with other stakeholders including staff from schools, CFCs and other government agencies and Learning Services specialist staff as required.
4. Undertake duties as required pursuant to being an authorised person under the Education Act 2016 and mandatory requirements under other Acts relevant to the Department.
5. Collect, collate and maintain student and/or family information and records to meet legislative and departmental requirements in relation to the Safe Homes, Safe Families program, to inform research and policy development and program evaluation.
6. In accordance with departmental guidelines provide mentoring, support and professional practice supervision to colleagues.
7. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

## Selection Criteria

Employment in the State Service is governed by the *State Service Act 2000* and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and
- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

---

1. Ability to interact and work effectively in the three different modes of social work practice; individual, group and community, in an educational environment.
2. Demonstrated knowledge, skills and experience in the provision of social work services, particularly in relation to support for children and families impacted by family violence.
3. Proven ability to relate to students, parents, school and CFC staff and other relevant professionals together with sound oral, written communication and interpersonal skills and demonstrated capacity to utilise appropriate resources to assist students and families.
4. Proven organisational and problem solving skills, and the ability to work as a member of a team with key stakeholders including staff from other government agencies, CFC and school staff and Learning Services Specialist Support Staff.
5. Proven ability to work in inclusive educational and community environments and respond to systemic and local needs in relation to family violence matters.

## Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times whilst employed in this role and the status of these may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Employer if their circumstances change. This includes notifying the Employer of any new criminal convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.

### Essential

- The *Registration to Work with Vulnerable People Act 2013* requires persons undertaking work in a regulated activity to be registered. A regulated activity is a child related service or activity defined in the *Registration to Work with Vulnerable People Regulations 2014*. This registration must remain current and valid at all times whilst employed in this role and the status of this may be checked at any time during employment.

- Tertiary qualification/program of study accredited by the Australian Association of Social Workers (AASW) and is a full member of AASW or is eligible for membership with the AASW.

### Desirable

- A current driver's licence.
