### Primary Purpose

Undertake routine technical tasks and provide basic assistance to other employees and clients under close supervision and direction. Tasks include the provision of technical advice on publications and information access and undertaking technical duties that include collection management procedures and bibliographic tasks.

## Level of Responsibility/Direction and Supervision

Responsible for undertaking routine tasks according to existing processes with strictly limited scope and discretion. An occupant at this level will, as experience and knowledge is gained, undertake a greater range of tasks and accept responsibility for the successful execution of those tasks.

The occupant works within established guidelines under close technical direction and supervision. Clear and detailed instruction is provided which will include written instructions and manuals. Initially limited in scope as experience develops the occupant will be expected to work with reducing levels of technical and general supervision. However, overall priorities will still be determined by the supervisor.

The Department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.

## Primary Duties

---

1. Undertake a range of routine technical tasks necessary to maintain library and information services:
  - amend, retrieve and maintain bibliographic records and holdings and construct basic records in accordance with national and international standards;
  - maintain and provide technical support and training in the use of a range of multi media and other equipment used in information access, distribution, retrieval and control;
  - apply established standards to the storage, maintenance and preservation of library materials;
  - guide and assist clients in retrieving information;
  - gather and collate technical information for professional library staff;
  - assist in collection management and assessment; and
  - operate and maintain manual and automated library control systems.
  - assist in the development and delivery of public programs and community outreach initiatives.
2. Assist in training less experienced staff in routine technical tasks and procedures.
3. Apply quality assurance procedures as required.
4. Undertake routine clerical duties associated with the above tasks that may include processing basic financial transactions.
5. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

## Selection Criteria

Employment in the State Service is governed by the *State Service Act 2000* and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and
- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Sound interpersonal and communication skills.
2. Able to work with the public, be consistently courteous and helpful and provide a high standard of customer service.
3. Personal skills of initiative, flexibility and motivation coupled with the ability to work effectively both in a public and a team environment
4. Demonstrated skills and experience in the use of computers and standard software programs, and capacity to work with emerging IT applications and devices as relevant to Libraries Tasmania business.
5. Demonstrated clerical skills including numeracy, literacy, filing, shelving, accuracy and data interpretation.

## Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times whilst employed in this role and the status of these may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Employer if their circumstances change. This includes notifying the Employer of any new criminal convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.

**Essential**
