### Primary Purpose

Travel with students on school buses and supervise students with disabilities and/or developmental delays whilst they travel to and from school

## Level of Responsibility/Direction and Supervision

Responsible for ensuring the safety of nominated students whilst travelling to and from school on the bus. Direction received from the Principal in relation to the principles and practices of the position. Expected to exercise some judgement in day-to-day situations

The Department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.

## Primary Duties

---

1. Supervise and control the behaviour of students whilst on the bus.
2. Ensure the safety of all students on the bus.
3. Administer appropriate first aid when necessary.
4. Escort students from the bus to an appropriate adult if considered necessary.
5. Advise the Principal in the event of behaviour or incidents which have or may endanger students on the bus.
6. Convey messages and medication to and from parents and the school, to ensure the well being of students.

The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

## Selection Criteria

Employment in the State Service is governed by the *State Service Act 2000* and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and
- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Proven communication and interpersonal skills with both adults and students.
2. An understanding of how to work effectively with students with disabilities.
3. Proven capacity to work as part of a team.
4. Personal skills of initiative and self-motivation.

## Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times whilst employed in this role and the status of these may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Employer if their circumstances change. This includes notifying the Employer of any new criminal convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.

### Essential

- The *Registration to Work with Vulnerable People Act 2013* requires persons undertaking work in a regulated activity to be registered. A regulated activity is a child related service or activity defined in the *Registration to Work with Vulnerable People Regulations 2014*. This registration must remain current and valid at all times whilst employed in this role and the status of this may be checked at any time during employment.
