Primary Purpose

Provide high level support to the Learning Services Student Support Team across a broad range of areas, with a focus on: the development, implementation and improvement of policies and procedures related to Student Support, together with support of high level departmental requests and the provision of advice to schools and colleges on related matters.

Level of Responsibility/Direction and Supervision

Responsible for providing accurate, efficient, and timely information and support to the team including providing advice to schools and colleges, particularly in relation to the department's Student Support policies and procedures.

The occupant is expected to work with minimal supervision. General direction will be provided by the supervisor.

The occupant is expected to be able to use initiative and exercise discretion in resolving non-standard issues.

The Department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.

Primary Duties

1. Assist in the administration, development, coordination, implementation, reporting and monitoring of the department's policies and procedures relating to student support.
2. Liaise, negotiate, and provide advice on the department's policies and procedures to the Student Support team, schools and colleges, external stakeholders, and other agencies.
3. Develop and implement improvements to practices, related to preparing correspondence, briefings, data gathering and reports by providing high level information management, research, and analysis to senior management in the Student Support team.
4. Represent and assist with emerging issues, processes, and provide accurate information and advice when required.
5. Manage the process of Part-time Attendance, Exemptions and Applications for Year 13, providing accurate research and assessment to senior management and advice to schools and colleges.
6. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

Selection Criteria

Employment in the State Service is governed by the *State Service Act 2000* and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and
- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Demonstrated ability to understand and work to policies and procedures including the ability to identify and implement opportunities for continuous improvement.
2. Highly developed interpersonal skills with a proven strong client focus and the ability to communicate effectively, consult, and negotiate with a range of community stakeholders,
3. In depth planning, research, analysis, and investigative skills including the ability to evaluate, analyse and exercise independent judgement to solve often complex issues.

4. Demonstrated ability to work successfully under pressure in a team environment to meet outcomes within strict timeframes,
5. Demonstrated capacity for initiative and flexibility, with the ability to work independently with limited supervision.

Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times by the occupant who is assigned these duties. The status of these essential requirements may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Department if their circumstances change. This includes notifying the Department of any new criminal charges or convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.

Essential

- The *Registration to Work with Vulnerable People Act 2013* requires persons undertaking work in a regulated activity to be registered. A regulated activity is a child related service or activity defined in the *Registration to Work with Vulnerable People Regulations 2014*. This registration must remain current and valid at all times whilst employed in this role and the status of this may be checked at any time during employment.
