### Context

Working Together - supporting early learning is a co-designed Tasmanian Government initiative designed to support opportunities for eligible children in the year before Kindergarten to participate in free, quality early learning. The program supports capacity building for children and families through the provision of holistic support, and facilitates Early Childhood Education and Care (ECEC) quality practice through the delivery of professional learning and practice support to ECEC service partners.

## Primary Purpose

Lead, coordinate and manage the operational delivery of the Working Together program across Tasmania, including delivery of outreach services to families in a range of regional locations and proactive engagement with the program's ECEC service partners.

## Level of Responsibility/Direction and Supervision

Responsible for the effective management of the operational delivery of the Working Together program, including management of the program's operational resources and leadership, direction and support for staff undertaking outreach and educational support activities in a range of regional locations across Tasmania.

The occupant is responsible for the management of contracts with ECEC service partners and supporting proactive service-to-service relationships across the family support and education service sectors.

The occupant is expected to exercise professional judgement and initiative and work with a high degree of autonomy on a day-to-day basis, with broad direction from the supervisor, in the achievement of the department's strategic plan.

The department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.

## Primary Duties

---

1. Lead and manage staff and resources allocated to the Working Together program (human, physical, financial and information), to ensure the effective delivery of quality services and programs.
2. Provide strategic and continuous service improvement leadership, including liaising and collaborating with partner organisations, to ensure program delivery to the community, and resolving any staffing issues
3. Supervise the development, implementation and maintenance of integrated service and community networks, to provide support to relevant families and communities.
4. Co-ordinate the development, implementation and maintenance of appropriate policies, procedures, benchmarks and reporting frameworks, to ensure that the Working Together program is delivered at high standards and to the benefit of children, families and the community.
5. Develop and maintain comprehensive service plans that incorporate strategies, timeframes, risk assessments and reporting stages, resulting in the delivery of the program in line with expected standards.

6. Provide authoritative advice and recommendations to senior staff and relevant stakeholders, in line with the department's strategic priorities, and represent the department and other relevant committees as required.
7. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

## Selection Criteria

Employment in the State Service is governed by the *State Service Act 2000* and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and
- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Proven leadership, performance and resource management skills in an educational or family support setting, with demonstrated capacity to achieve improved outcomes for those being supported by the service.
  2. High level of initiative, adaptability and flexibility, together with a proven ability to develop and maintain relationships and networks across the business, community and government sectors, and to work collaboratively with organisations at senior levels in the planning and delivery of collaborative projects and initiatives.
  3. Proven high-level strategic, conceptual, analytical and innovative skills, including the ability to understand and balance a range of priorities in a complex service and community environment, particularly in an education setting.
  4. Demonstrated high-level project management skills, with the ability to develop appropriate plans, briefings, procedures and systems.
  5. High-level interpersonal skills, including written and verbal communication, negotiation and conflict resolution skills, together with a demonstrated ability to develop collaborative relationships with other organisations, service providers and team members, to facilitate the development of quality services.

## Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times by the occupant who is assigned these duties. The status of these essential requirements may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Department if their circumstances change. This includes notifying the Department of any new criminal charges or convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.
