### Primary Purpose

To provide high level support and assistance with project management and programs including the development of associated procedures, policies, tools, resources and guidelines to ensure that Inclusion and Cultural Diversity Services timelines are met.

### Level of Responsibility/Direction and Supervision

The occupant is responsible for providing strategic project management and advice together with supporting the delivery of key policies, projects and programs within Inclusion and Cultural Diversity Services, including governance, management of scope, time and resources, monitoring and reporting functions.

The occupant is expected to be proactive, exercise initiative, discretion and judgment in the management and lead of allocated tasks.

The occupant will work within the framework of departmental plan and policies and through the managerial structure of the Division and receives direction, guidance and general advice from the Director, Inclusion and Cultural Diversity Services

The Department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.

## Primary Duties

---

1. Undertake research, analysis, assessment and provide advice and support in the development, implementation, and monitoring of projects and policy development relating to Inclusion and Cultural Diversity Services
2. Support the development and maintenance of a comprehensive project plan/s, incorporating strategies, timeframes, risk assessments and reporting stages for the successful implementation of the priority projects.
3. Support the development of operational and strategic elements within Inclusion and Cultural Diversity Services
4. Assist with the provision of communication, evaluation, progress reports, advice and recommendations in relation to Inclusion and Cultural Diversity Services as required.
5. Undertake activities to implement core aspects of Inclusion and Cultural Diversity Services (i.e. Procurement and Grants)
6. Perform other duties as envisaged by the assigned classification under the relevant industrial award or agreement and in accordance with the skills, competency and training of the occupant.

## Selection Criteria

Employment in the State Service is governed by the *State Service Act 2000* and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and
- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Demonstrated high level project management skills including the ability to develop policies, procedures and programs together with the risk management of projects
2. Proven conceptual, analytical, research and strategic skills associated with the development, communication and implementation of policy, guidelines and advice, including the ability to document the results and recommendations of research and analysis.

3. Highly developed interpersonal skills including oral and written communication skills with the ability to communicate effectively with a wide range of internal and external stakeholders, including other government agencies.
4. Demonstrated capacity to exercise initiative, flexibility, innovation and self-motivation, together with the ability to think critically and solve problems, work both independently and as an effective member of a team, and to set priorities and manage a variable workload.
5. Knowledge, or the demonstrated ability to rapidly acquire knowledge, of departmental priorities, policies, programs and initiatives.

## Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times whilst employed in this role and the status of these may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Employer if their circumstances change. This includes notifying the Employer of any new criminal convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.

### Essential
