Primary Purpose

Facilitate effective workplace relations through the provision of high quality human resource consultancy services to senior management and employees.

Level of Responsibility/Direction and Supervision

The occupant is directly responsible for providing high level consultancy and representational services on a range of human resources and workplace relations matters, including case management.

The occupant works independently in day to day activities and receives limited supervision from the Manager Workplace Relations. The occupant is expected to develop and achieve standards and outcomes within the framework of operational and strategic objectives.

The Department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.



Primary Duties

- 1. Provide high-level consultancy and advisory services to executive management, principals, managers and Learning Services on workplace relations matters in particular employee relations, performance management, and conduct and investigation matters.
- 2. Undertake the case management of employee relations matters including representing the Department before administrative and industrial tribunals and in negotiations with employee organisation representatives.
- 3. Undertake research and investigations into complex workplace relations matters and make appropriate recommendations, including preparing correspondence and reports.
- 4. Participate in the development and implementation of policies and strategies which:
- 5. support the provision of quality workplace relations services;
- 6. enhance departmental relations with employees and employee organisations; and
- 7. ensure adherence to relevant legislation, Directions, industrial Awards and agreements.
- 8. Investigate complaints, grievances, inability and disciplinary allegations as directed and prepare associated recommendations and documentation
- 9. Manage and/or participate in designated projects.
- 10. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

Selection Criteria

Employment in the State Service is governed by the State Service Act 2000 and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and
- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

I. Demonstrated high level knowledge, experience and understanding of contemporary human resources management issues, particularly as they relate to workplace relations and performance management issues.

- 2. Demonstrated high level investigative, influencing and negotiation skills.
- 3. Proven high level communication, representational, consultancy and relationship management skills including the ability to operate in a team environment.
- 4. Proven high level strategic, conceptual, analytical and creative skills with a focus on influencing and facilitating effective business outcomes.
- 5. Demonstrated experience and knowledge of the policy formulation and implementation process.
- 6. Demonstrated planning and management skills, including the ability to identify priorities and manage designated projects.

Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times by the occupant who is assigned these duties. The status of these essential requirements may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Department if their circumstances change. This includes notifying the Department of any new criminal charges or convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.
